Mini Trial Fees: \$130 for Pre-Starter, \$150 for Starter, Beginner Novice, and Novice. XC over rolling terrain, welcoming courses, no water, BN and Novice may have ditch and/or bank. No double entries. No additional jump rounds allowed.

Combined Test Fees: \$85, or \$150 for 2 consecutive levels (same horse rider combination), double entries allowed, second test/round hors concours. All tests ridden in small ring except Intermediate.

Additional Jump Rounds: \$20 if already in same CT division, \$35 if a lower CT division or not competing in CT.

Dressage Class Fee: \$45 per ride, double entries allowed, second ride of same test hors concours. Classes 1-4 and 9 will be ridden in small ring, classes 5-9 in large ring. Classes may run out of order. Class 1 and 10 may have a ring size change to accommodate upper level tests.

Refund: Refund in full less \$20 office fee prior to closing date. No refunds after close date, all changes must be in writing to organizer.

Attire: Approved helmets and footwear must be worn at all times while riding. Braiding and coats not required. Riders must bring pinny holders for XC. *Medical armbands and protective vest must be worn on cross-country.*

Ride Times: Will be available on facebook page, email, and website by September 21.

Facilities: Limited stabling available at \$80/night. Shavings \$10/bag. RV hook-ups \$40/night. Sand show rings, grass warm-up. Concessions available on site. Ribbons 1-6th.

Entries: Send entries to Lindsey DeAngelis, 128 Ashley Inn Way, Lancaster, KY 40444. Coggins and payment must be sent with entry. Entries must be postmarked by CD or incur \$25 late fee. Check website for link to online entry.
