**Combined Test Fees:** \$65, or \$100 for 2 consecutive levels (same horse and rider combination)

**Jumper Derby:** \$25 (to run at conclusion of each CT Division)

**Additional Jump Rounds:** \$10 each round. (Available to anyone entered in CT or Jumper Derby)

**Dressage Class Fees:** \$25 per class

**Lead Line:** \$20 to be held prior to start of stadium

**Refund:** Refund in full less \$20 Office Fee prior to closing date. No refund after closing date unless spot filled from wait list (less \$20 Office Fee).

All changes must be in writing to organizer at email shown above.

**Attire:** Approved helmets and footwear must be worn at all times while mounted. No coats or braiding required.

**Awards:** Ribbons 1st–6th Place. Prizes for all first place finishers. Anyone who competes in at least two of the three shows will be eligible for Champion and Reserve Champion series awards.
